
Having perused the papers filed of record and having heard Counsel for the Applicants, it is hereby ordered as follows:-

- 8. The First, Second and Fifth Respondents and all other Respondents are interdicted from utilising the newly registered non-profit company (NPC) named Higher Education Transformation Network with a registration no 2016/046790/08 and interdicted from pretending to act on behalf of the Applicant.
- 9. The Seventh and Eighth Respondents are hereby called upon to show cause why they should not deregister the nonprofit company registered as Higher Education Transformation Network (HETN) under registration no 2016/046790/08 registered on the 3<sup>rd</sup> February 2016.
- The Seventh and Eighth Respondents are hereby called upon to show cause why they should not stop the trademark application no 2016/02178 lodged on the 27<sup>th</sup> January 2016.
